Miscellaneous collections include LCB (\$102M), out of state vehicle sales (\$2.0M), and other out of state, unallocated, and separately remitted use tax collections (\$2.9B), and for the purposes of this analysis are prorated based on relative county and vehicle collections.

² Distribution 50% county, 40% municipality, 10% cooperative services delivery.

³ Amount shown represents 60% of county sales tax receipts, the minimum required to be used as offset of county property tax; actual reductions likely to be greater. Required municipal reductions not shown.

⁴ Statewide amount for the County Option Sales Tax proposal, omitting Allegheny and Philadelphia counties, which would not be authorized the new levy.

⁵ The commonwealth sales tax collections data for Allegheny and Philadelphia counties do not represent collections from sales subject to local sales and use tax. Neither county would be authorized the new tax so distribution data is for illustrative purposes only, and no reduction is shown since offsets are already taken under other law.
