PCCD Funding Announcements

The Pennsylvania Commission on Crime and Delinquency (PCCD) and the Department of Human Services (DHS), Bureau of Juvenile Justice Services (BJJS) have announced the availability of \$675,000 in 2025 PACTT Non-Compete state funds.

This is a non-competitive solicitation that is limited to privately operated residential facilities, schools in the Youth Development Center/Youth Forestry Camp system, community-based providers, and juvenile probation offices that are existing PACTT Affiliates. Funds may be used to improve services for system involved youth in academics, job readiness, and employability skills.

Interested applicants should consult the funding announcement to determine whether they are available, and for what possible tier of funding.

These awards will run for 12 months, beginning April 1, 2026, with an end date of March 31, 2027. PCCD has streamlined the application process for general convenience. Applications are due in the PCCD Egrants system by October 10, 2025.

Pennsylvania Commission on Crime and Delinquency (PCCD) Office of Justice Programs announces the availability of <u>2026 Residential Substance Abuse Treatment (RSAT) Program</u> funding. Under this solicitation, federal funds are being made available to support counties seeking to increase opportunities to provide Medication Assisted Treatment (MAT) in combination with Cognitive Behavioral Therapy (CBT) to individuals in county jails and upon release to the community.

A total of \$1,130,905 in federal Residential Substance Abuse Treatment (RSAT) funds is being announced to support this initiative. PCCD expects to fund approximately five grants with budgets not to exceed \$200,000 over the 21-month project period.

Funding is available to Pennsylvania counties, county jails/county work release centers, Single County Authorities, and/or County Behavioral Health Administrators seeking to establish or expand a jail-based substance use treatment program that supports individuals transitioning from a county jail and/or work release center to the community.

Applicants receiving prior funding through PCCD to support county jail-based MAT programs are eligible to apply under this funding announcement if these funds will allow for the expansion or enhancement of relevant substance use disorder treatment programs supporting individuals who are currently incarcerated, and those transitioning from a county jail to the community.

This grant requires a 25% match of funds. Federal funds awarded under this solicitation may not cover more than 75% of the total costs of the project being funded. An applicant must identify the source of the 25% non-federal portion of the total project costs and how match funds will be used. Federal funds may not be used to meet the match requirement.

Applications must be submitted in <u>PCCD's Egrants</u> system no later than 11:59 P.M. on Wednesday, October 8, 2025.

The <u>SNAP Work Requirements</u> page provides guidance for individuals to determine how federal changes to the program may affect them personally. The page includes important dates, lists of the requirements, frequently asked questions, forms, and how to contact representatives for further assistance.

Individuals with questions about how to report work, education, training, or volunteering activities can contact their caseworker at DHS' County Assistance Office or call the Customer Service Center at 877-395-8930 (or 215-560-7226 if you live in Philadelphia).

Pennsylvanians should also keep their address up-to-date with DHS by calling the Customer Service Center or updating their address through <u>COMPASS</u>, and with the United States Postal Service so they don't miss any important mailings about their benefits.
