



Opioid Solutions Leadership Network (OSLN) Meets in DC

The Opioid Solutions Leadership Network (OSLN) was launched in 2022 to bring together county leaders-such as Butler County Commissioner Kevin Boozel-to strengthen strategies for addressing the opioid crisis.

In 2025, the network expanded its reach by inviting state associations, including the County Commissioners Association of Pennsylvania (CCAP), to participate as ambassadors.



CCAP joined eight other states in a collaborative effort to advance the effective use of opioid settlement funds. As part of this work, CCAP's Human Services and Criminal Justice Policy Director, Melanie Gordon, participated in an inperson summit held in Washington, DC on November 6.

This summit capped a yearlong initiative aimed at improving support for Counties and state-local coordination with these time-limited resources.
