### Pennsylvania Commission on Crime and Delinquency Grants

The Pennsylvania Commission on Crime and Delinquency (PCCD) is now accepting applications for the following grants;

- A total of \$16,150,000 **FY 2025-26 Continuing County Adult Probation and Parole Grant** (CCAPPG) funds. Eligibility for these funds is open to counties that provide adult probation staff and may be used for costs incurred by the county for adult probation

and parole services, but only to the extent that the staff and program meet the qualifications and standards established by the Commission. Applicants must be in good standing with PCCD to be eligible for these funds.

These funds are non-competitive, with the amount available to each county listed in the Appendix to the [funding announcement](#). Funds approved will be eligible for 12 months of expenses from July 1, 2025, to June 30, 2026.

Applications must be submitted in PCCD's [Egrants](#) system no later than 11:59 P.M. on **Wednesday, December 18, 2025**.

- **Funding under the FY 2025-26 Intermediate Punishment Treatment Program Initiative.** The primary purpose of this grant program is to support restrictive conditions imposed as part of county probation. Act 115 of 2019 replaced County Intermediate Punishment (CIP) as a sentencing option with an Order of Probation, for which restrictive conditions may be imposed. CIP programs are restrictive conditions of probation imposed under section 9763 (c) or (d) (relating to adoption of guidelines for restrictive conditions). The goal of the FY 2025-26 Intermediate Punishment Treatment Program remains to divert individuals from county jail or state prison and provide the necessary treatment for individuals with substance use or mental health disorders, thereby reducing recidivism and increasing public safety.

These funds are non-competitive, with the amount available to each county listed in the Appendix to the [funding announcement](#). Funds approved will be eligible for 12 months of expenses from July 1, 2025, to June 30, 2026.

Applications must be submitted in PCCD's [Egrants](#) system no later than 11:59 P.M. on **Wednesday, December 18, 2025**.

## SAMSHA GAINS Center Opens Application for Sequential Intercept Model (SIM) Mapping Workshops

The GAINS Center is currently [soliciting applications](#) from communities interested in a Sequential Intercept Model (SIM) Mapping Workshop.

SIM Mapping Workshops are designed to bring together local key partners from a particular jurisdiction (typically a county) to facilitate collaboration and to identify and discuss ways in which barriers between the criminal justice and behavioral health systems can be reduced through the development of integrated local strategic action plans.

SIM Mapping Workshops focus broadly on identifying and responding to the needs of adults with mental health conditions and substance use disorders who are involved or at risk for involvement in the criminal justice system.

The GAINS Center will provide the SIM Workshops free of charge to selected applicants between April and August 2026. There are no fees for registration, tuition, or materials associated with these workshops. The GAINS Center will cover all costs associated with pre- and post-workshop planning and coordination, travel and lodging, facilitation, data collection and analysis, and report development. The GAINS Center plans to conduct all the SIM Mapping Workshops in person.
